The approximate waiting time is now 0-1 year.

The membership fee is \$750.00, which consists of a \$150.00 initiation fee and a \$600.00 refundable bond. **There is 6.875% NJ Sales Tax on the initiation fee.**

This charge does not include the annual dues, which are assessed separately.

1. The enclosed application form must be completely filled out and returned as specified below.
2. A check in the amount of \$106.88 (\$100 deposit + \$6.88 NJ Sales tax) payable to the Teaneck Swim Club must accompany your application form. \$100 will be returned to you if you withdraw from the waiting list, or will be applied to your membership fee if you decide to become a member.
3. Numbers will be assigned in the order in which applications are received by the Financial Secretary.
4. When an opening becomes available, you will be notified by telephone when it is your turn. You will then be required to pay \$653.44 in one payment within 3 weeks after notification.
5. In the event that circumstances make it impossible to become a full member at the time you are called, and you wish to stay on the waiting list, your name will be placed on the bottom of the list.
