Returning Member Information

1. The attached renewal form must be filled out completely and returned as specified below.
2. If there is an error in your invoice or a change in your membership status, please email membership@teaneckswimclub.org.
3. A payment to Teaneck Swim Club should accompany your information form. See payment options below. A late fee of \$25 will be charged if your first payment is received after March 25. An additional late fee of \$25 will be charged if your second payment is received after May 15.
4. Returning members who do not have a full bond (Teaneck residents) or bond equivalent (non-Teaneck residents) must contribute to a \$500 per family bond. Until the bond is completely paid, members will be considered "pre-bonded" and will not have voting rights, may not serve on the Board of Trustees or be eligible for a refund after resignation. All resignations must be submitted in writing before March 25th of any calendar year.
5. Returning (non-senior) members with no bond must use the new member application. Returning senior members should fill out this form.
6. Once payments are complete, you may come to the club during normal business hours. Badges must always be presented to gain access to the swim club.
7. The 6.625% New Jersey sales tax on dues is included in your payment.
